Paul Schiavone, Global Chief Underwriting Officer Specialty Lines, Zurich General Insurance

Paul is the Global Chief Underwriting Officer for Special Lines, Zurich General Insurance. Special Lines includes the insurance lines of business for D&O, Management Liability, Financial Institutions, Professional Liability, Surety, Political Risks and Trade Credit. In this role Paul is responsible for developing and implementing the global strategy and financial planning for Zurich's Special Lines, for Zurich General Insurance.

Paul joined Zurich Financial Services on April 1st, 2006 to be Chief Underwriting Office of Commercial D&O, EPL and PTL Insurance for Zurich Global Corporate. Paul has over 18 years of experience in the insurance industry and Financial Lines and has also worked for American Wholesale Brokerage in San Francisco, California and AIG in both New York and Paris.

Paul started his career in insurance 1994 working as Divisional Counsel for AIG's New York based subsidiary National Union Fire Insurance Company of Pittsburgh, Pa. (National Union). At National Union, Paul held many positions including Divisional Counsel for the middle market unit, Divisional Counsel for the commercial/national unit and Chief Underwriting Officer and Vice President of National Union. In March of 2001 Paul joined the Financial Lines Division of AIU (AIG's international arm of business) in New York as a Vice President, again focusing on D&O and EPL for all countries outside of North America. Paul subsequently moved to Paris with AIG in 2002 to be Chief Underwriting Officer for Financial Lines Europe. In 2004, Paul left underwriting to start a career as a broker for American Wholesale Brokerage Group, starting their Financial Lines office in San Francisco, leaving this position in 2006 to join Zurich. At Zurich Paul has held the positions of Global CUO for D&O, EPL and PTL for Zurich's Global Corporate Unit, Global Head of Zurich's Mergers and Acquisitions Insurance Group and Global CUO for D&O, Management Liability and Financial Institutions for Zurich General Insurance.

Mr. Schiavone graduated from Seton Hall University in 1990. He passed the New York and New Jersey bar in 1993. Mr. Schiavone obtained his law degree from New York Law School in Manhattan, graduating in 1993.
